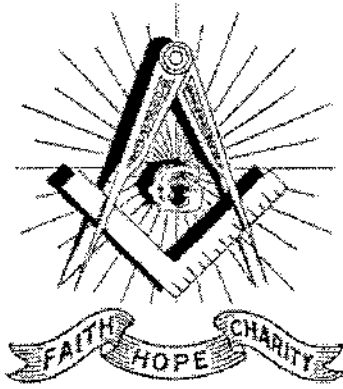

ANSWER: To prevent errors resulting from poor eyesight.

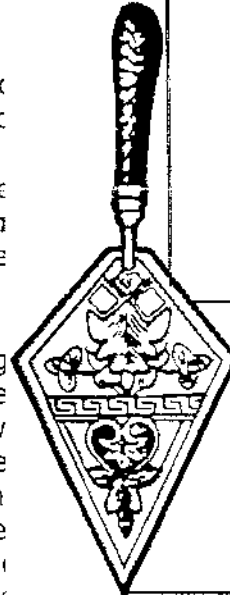

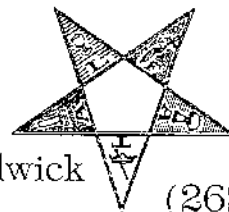

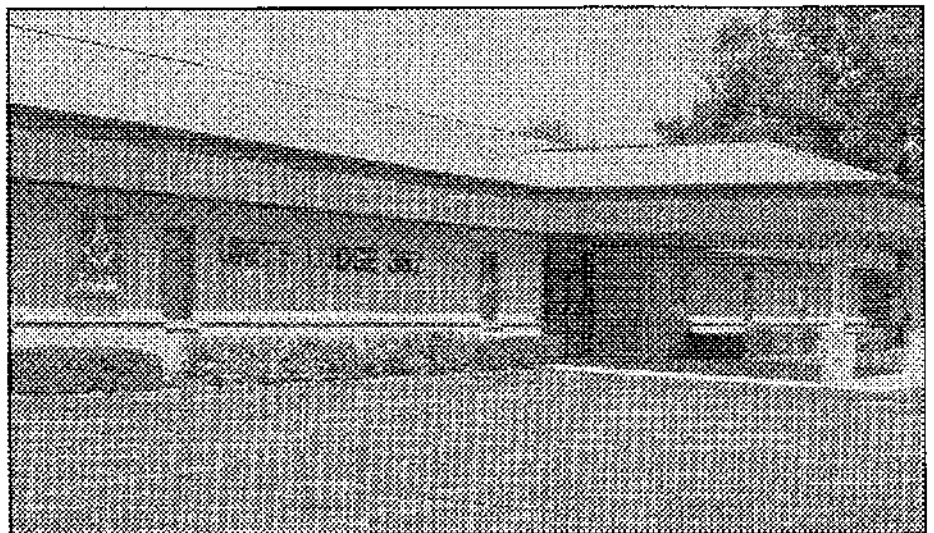
